# Benchmark Update - England

Key Stage 5, All KS5 qualifications

Updated 2020/21 benchmarks for A, AS levels and BTEC Level 3 in England will be in Connect Interactive from Results Day. We have created the new benchmarks from the full national dataset supplied by the Department for Education.

The purpose of this short briefing paper is to provide some headline information about the new Minimum Expected Grades that have been generated from these new benchmarks

## Headline changes:

Minimum Expected Grades (MEGs) for End of Year 2020 and Monitoring 2020/21

#### A level and AS level

The headline news for both A level and AS level is that where we have re-benchmarked, there is little change in the Expected Points for each prior attainment band, which has meant little or no change in the Minimum Expected Grades (MEGs) for each band or relative band.


#### BTEC

The benchmarking exercise showed little movement in the minimum expected points for the 2010 BTEC Suite, and therefore we have made the decision to retain the existing benchmarks. This means that there will be no change in your MEGs for the 2010 BTEC Suite.

The 2016 BTEC qualification suite has undergone the most significant change in benchmarking. Larger numbers of entries in the outcomes for these qualifications in 2019 means that we have a more stable picture of published results from which to construct our analysis. This is discussed later in this paper

### A level MEGs - 2020 End of Year and Monitoring 2020/21

### BTEC 2016 Suite - End of Year 2020 and Monitoring 2020/21

#### New benchmarks for L3 2016 BTEC / Vocational Qualifications (England)

Alps has always banded students with similar prior attainment (PA) into bands, both to help establish aspirational Minimum Expected Grades (MEGs) at the 75th% nationally and to then provide crisp and clear progress analysis mid-year and based on final results.

The 2016 BTECs are new qualifications, that had some uncertainty during their first couple of years of teaching. Now we have had a couple of years of national results, we have reviewed the profile of students taking these new qualifications and have readjusted the Alps PA bands. Bear in mind that many students in larger centres are still following the 2010 suite until the results in summer 2021.

Our analysis of the 2019 national data showed that in 2019 between 68% and 75% of all students who completed L3 2016 courses had PA between 3.31 and 4.76 (9-1 scale).





Because the 2016 courses are regarded as more demanding, fewer students with PA below 3.31 are being admitted into sixth forms to take these qualifications.

Our new Prior Attainment bands for the 2020 results redistribute the students more equally across 10 bands.

Table 4 below shows the Minimum Expected Grades (MEGs) for each band.

Our Data Team's research shows that compared to the MEGs used for target setting and monitoring during 2019/20, the MEGs for the vast majority of students either remain the same or are slightly lower.
